

PRESIDENTIAL DECREE No. 353/1997 (A' 239) "Retention of supervisory authority over Legal Entities Governed under Public Law by the Ministry of National Education and Religious Affairs"

Sole Article

The Ministry of National Education and Religious Affairs retains supervisory authority over the following Legal Entities Governed under Public Law falling within its competence:
